

**THE LONDON BOROUGH OF HAVERING (RAINHAM AND BEAM PARK HOUSING ZONE REGENERATION AREA)
COMPULSORY PURCHASE ORDER 2019 No.1**

**THE TOWN AND COUNTRY PLANNING ACT 1990 SECTION 226 (1) (a)
SECTION 13 LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976
AND THE ACQUISITION OF LAND ACT 1981**

The London Borough of Havering (in this order called ‘the Acquiring Authority’) makes the following order:-

1. Subject to the provisions of this order, the Acquiring Authority is under Section 226 (1) (a) of the Town and Country Planning Act 1990, Section 13 Local Government (Miscellaneous Provisions) Act 1976 and the Acquisition of Land Act 1981 hereby authorised to purchase compulsorily the land and the new rights over land at the Rainham and Beam Park Housing Zone Regeneration Area described in paragraph 2 for the purpose of facilitating the carrying out of development, redevelopment or improvement on or in relation to the land namely: the demolition of existing buildings on the land and the erection of new residential dwellings, community hall, associated landscaping and public realm works and interim works.
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the Acquiring Authority and marked “Map referred to in the London Borough of Havering (Rainham and Beam Park Housing Zone Regeneration Area) Compulsory Purchase Order 2019 No.1”
3. The new rights over land authorised to be purchased compulsorily under this order are described in the Schedule and the land is shown edged red and coloured blue on the map.
